

In order to keep our site operating properly and provide the best service for our users, we created rules for all users to follow.

These terms of service constitute the entire agreement ("Agreement") between you and ZechTech, LLC (the "Company") in relation to your use of this website ("Site"). Users who fail to obey the rules detailed in this document will have appropriate action taken on their account, including termination of your account. By creating a CryptoTask account, you agree to this policy and all of the terms introduced within it. CryptoTask is able at any time for any reason to change this policy, and by continuing to use our service you're assumed to understand the changes. We will make a consistent effort to notify users when we make significant changes but aren't required to, and you're expected to review these terms often.

Account Terminations

CryptoTask may at any time terminate (or "ban") accounts which we find that break the terms set in this document. This ban will restrict access to your account completely and will nullify any credits held within your account. The CryptoTask team can, without notice, terminate any account that we find that doesn't meet our standards.

Use of VPN, Proxies, Tor, or other identity concealing methods

While we are strong advocates for internet privacy, we **don't allow** these privacy concealing methods on our website. To avoid fraud and keep our site secure, users must connect with their actual local IP. Tampering or reverse-engineering website systems

Attempting to reverse-engineer, break, or otherwise bypass measures set in place by our website will lead to account termination. Users who accidentally encounter issues with our website should report them to our team instead of abusing them or sharing them with others.

Account Balance and its physical value

Account Balance is a number representing USD, that you can use to redeem rewards. This balance is **not insured**, has no real value on other sites, and can be altered at any time. There is no way to access this balance outside of the CryptoTask service. If for any reason your balance is changed without your consent, we are not required to re-credit your account or compensate you in any way.

Referral links and your representation of our affiliation

CryptoTask provides its users with a unique referral link to invite users to our platform in exchange for account balance and other perks. You must follow the guidelines below when using this link. Failure to follow these guidelines can lead to a reversal of all referral rewards, termination of your account, and in rare cases legal action:

- You must disclose that you are receiving compensation by users using your link to register on CryptoTask
- You must not spam the link and follow all platform rules if you wish to share it on a 3rd party platform
 - CryptoTask should not be held liable for misuse of this link
- You must not claim that we are officially affiliated with you
 - You are a normal user of our platform, whether you opt to share your link or not
 - You are NOT apart of the CryptoTask team, and at all affiliated with the operation of our site
 - We are not sponsoring you, your site, or any service you use to share this link.

You agree to the rules listed above, as well as the terms listed on your account settings page by using the referral system.

Eligibility

To use the Site, you must be at least 13 years of age. If you are at least 13 years of age but a minor where you live, you must have your parent or legal guardian read and accept this Agreement on your behalf.

Our partners may enforce different requirements and you must review their policies when interacting with their individual services. They don't directly represent CryptoTask or any of the terms listed in this document.

Third party content

We make no representations or endorsements regarding the quality, accuracy, reliability, security or condition of any third-party content, applications or websites; you acknowledge and agree that the Company and its affiliates are not responsible for examining or evaluating the accuracy, completeness, timeliness, validity, copyright compliance, legality, decency, quality or any other aspect of third-party materials. You are responsible for taking precautions as necessary to protect your property from viruses and other destructive mechanisms. We disclaim any responsibility for any harm resulting from your use of the Site through the viewing or use of any third-party content, technology, or websites.

Indemnity

You hereby agree to indemnify, defend and hold harmless the Company, its officers, directors, employees, agents, members, successors and assigns, from and against any and all claims, losses, damages or expenses (including attorney's fees and costs) of any nature whatsoever incurred or suffered by the Company arising out of any violation by you of any provision of this Agreement.

Severability

If a provision of this Agreement is determined by any court of competent jurisdiction to be unlawful and/or unenforceable, the remaining provisions shall remain in full force and effect. The parties shall in good faith attempt to modify any invalidated provision to carry out the parties' stated intentions. The waiver of any breach of any provision by any party shall not be deemed to be a waiver of any preceding or subsequent breach, nor shall any waiver constitute a continuing waiver.

Acceptable Use

You must not use the Site in any way that causes, or may cause, damage to the Site or impairment of the availability or accessibility of the Site, or in any way which is unlawful, illegal, fraudulent, or harmful. Should the Company detect any instances of fraud, system abuse or any type of activity deemed to be inappropriate or illegal in the sole discretion of the Company, these actions may result in suspension of Site access as well as forfeiture of any earned commissions not yet disbursed to you by the Company.
